**This one day course is a total of 9 hours**, 8 of which are required by ORC 2923.125 and House Bill 234 for an individual to apply for an Ohio Conceal Handgun License. Class is taught by NRA certified instructors.

**Classroom** will be held at Ohio Armament, 1315 N Wooster Ave, Strasburg Ohio. Enter through the first door on left with the ‘classroom’ sign on the door. Class time will be from 11:00 a.m. until 5:30 p.m. Material covered will be the “NRA New Shooter Guide” handbook, the NRA’s rules for safe gun handling and storage; pistol parts and operation; ammunition and safe storage; cleaning the pistol; and continued opportunities for skill development. Students will also review the Ohio Attorney General’s pamphlet “Ohio’s Concealed Carry Law”.

***We will take an hour break for supper.***

**Range time** will be held from 6:30 p.m. until 9:00 p.m. Material covered will be: pistol and holster selection, shooting fundamentals, range rules, and a minimum of two hours of live fire exercises.

**Participants must pass:** 1) a written test covering safe gun handling and safe storage of guns and ammo, 2) physically demonstrate safe gun handling, and 3) qualify on the range in order to receive the course completion certificate.

**Students are required to bring:** eye and ear protection, good quality handgun (**double action revolver with two speed loaders/speed strips or a semi-automatic handgun with two magazines**) & 150 rounds of quality ammo. If you are bringing your own handgun – *you will need to have the pistol approved by us first.* 22’s, 38’s, 9mm, 40, 45 caliber handguns are acceptable. *No magnum calibers permitted.* If you do not have a handgun, we will have quality 22 handguns and ammo available for an additional \$25.00.

**Cost:** \$95.00 per student (\$25 non-refundable deposit is due by July 15<sup>th</sup> & the balance is due the day of class. Price includes classroom instruction, printed materials, and range time. *We discount the class by \$5.00 each if your spouse takes the class along with you.* Cost of the class **does not** include the cost of the students concealed carry handgun license. Prior handgun experience is beneficial but not necessary.

***Please note: a conviction of any felony, certain misdemeanor convictions pertaining to drugs or violence, or of domestic violence will prevent you from obtaining an Ohio CHL. Contact legal counsel if you have any questions.***

**Personal Protection Gear is your choice but not required – if you plan to wear gloves, they must be nitrile or latex. We will do our best to keep with the social distancing requirements.**
